Nominees for Board of Directors Announced

Your Nominating Committee has selected their nominees for the three available 3-year terms on the TVFCU Board of Directors. They are incumbents Judy Field, John Pogue and Louis Wright.

Judy Field served on TVFCU's Supervisory Committee for more than 13 years before becoming a board member in 2019. She is retired from BlueCross BlueShield of Tennessee as audit manager in Provider Reimbursement.

John Pogue has served on the TVFCU Board since 1981 and is the current Secretary. He retired after 29 years of service with TVA.

Louis Wright has served on TVFCU's Board since 1996 in various roles, including Board Chair. After 39 years of service in Hamilton County Government, he retired as Administrator of Finance.

The election procedure will be the same as in the past several years. According to TVFCU's bylaws, if there is only one nominee for each available position, then a mail ballot will not be conducted and the nominees listed here will automatically be elected to fill the vacancies.

No nominees will be accepted from the floor at the Annual Meeting. The Credit Union does, however, allow for other nominations

In accordance with our bylaws, any member in good standing may be nominated for the Board of Directors by petition. Regulations require the petition to be signed by 1% of the membership, up to a maximum of 500 members. Joint owners of accounts cannot be considered in the 1%

total. Each member may sign a nominee's petition once. All signatures must be from members 16 years of age or older and are subject to verification by TVFCU's Supervisory Committee.

Petitions are available at TVFCU's Executive Office at 535 Chestnut Street in Chattanooga. They must be returned to the Supervisory Committee by close of business (4:45 p.m. ET) on **Friday, Feb. 14**, in order for the nominee to be placed on the ballot.

If a nomination by petition is received, we will hold an election and the results will be announced at our 84th Annual Meeting on Tuesday, May 5. This year's meeting will be at The Collegedale Commons, 4950 Swinyar Drive, Collegedale, at 7 p.m. ET. Doors will open at 5 p.m. ET. Learn more in the next issue of Currents in early April.
